ITEM TITLE	Parent Carl Armbruster inquired about the possibility for Flag Football practices to begin sooner.
DISCUSSION NOTES	Mr. Mery received a request from parent Mr. Armbruster to discuss the possibility of having flag football practices earlier in the school year before the November 2025 flag football competition. It was just amongst the Site Council members that the flag football tournament is a one-day event, the coach is an unpaid passion, the flag football team will be permitted to use the four football fields during lunch, have a tax credit line provided for parent donations, and for students to fill out their forms ahead of time. Beginning next school year, flag football can be a club style organization where Mr. Mery will volunteer his time to this with students and an agreed upon time, possibly during 7th and 8th grade lunch.
